Spoter Is a initiative of WEBINOVATION .The Distributor shall be District wise. The basic qualification for registration as DISTRIBUTOR shall be 10th Pass. Marketing Agencies/ Companies dealing in information technology products shall also be allowed to register as DISTRIBUTOR. Acceptance / rejection of distributor application are sole responsibility of Spoter Only.

- 1. The DISTRIBUTOR's shall pay non-refundable Rs. 25,000/- as franchisee fee. And you get a business startup kit including one pcs of GPS device for demo purpose.
- 2. The DISTRIBUTOR's minimum order quantity is 5 [Five] pieces for issue any kind of purchase order. The total amount deducting Distributor's commission, shall payment in advance and material will be supplied after 10 to 15 Working Days as its hardware is imported from abroad.
